CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

HAROLD S. HUBER AND JAMES S. BLOODSWORTH

confirms the right to use the waters of WILLOW CREEK, a tributary of COLUMBIA RIVER, for the purpose of IRRIGATING 82.25 ACRES.

The right has been confirmed by decree of the Circuit Court of the State of Oregon for MORROW County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 1, at page 73. The date of priority is 1883 FOR TRACT 1 AND 1902 FOR TRACT 2.

The right is limited to not more than 1.37 CUBIC FEET PER SECOND BEING 1883 FOR 0.76 CFS AND 1902 FOR 0.61 CFS, IF AVAILABLE AT THE ORIGINAL POINTS OF DIVERSION; SW 1/4 NE 1/4 & SE 1/4 SE 1/4, SECTION 1, T 2 S, R 25 E, W.M.

The points of diversion are located as follows:

SW 1/4 NE 1/4, SECTION 1, T 2 S, R 25 E, W.M.;
POINT 2 - 920 FEET NORTH & 160 FEET EAST; POINT 3 - 910 FEET NORTH & 140 FEET EAST BOTH FROM CENTER 1/4 CORNER SECTION 1.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-SIXTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated during the irrigation season of each year.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

This certificate is issued to confirm a change in PLACE OF USE AND POINT OF DIVERSION approved by an order of the Water Resources Director entered DECEMBER 20, 1979 and supersedes certificate 202, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and shall be subject to all other conditions and limitations contained in said decree.
