CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

MILLER RANCH COMPANY
807 EAST 18TH
THE DALLES, OREGON 97058

confirms the right to use the waters of EIGHTMILE CREEK AND RESERVOIR CONSTRUCTED UNDER PERMIT R-5299, a tributary of THE COLUMBIA RIVER, for the purpose of IRRIGATING 25.9 ACRES AND LIVESTOCK.

The right has been perfected under Permit 38157. The date of priority is MAY 24, 1973. The right is limited to not more than 0.34 CUBIC FOOT PER SECOND; BEING 0.32 CFS FOR IRRIGATION AND 0.02 CFS FOR LIVESTOCK, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

SE 1/4 SE 1/4, SECTION 25, T 1 S, R 12 E, W.M.; RESERVOIR-800 FEET NORTH AND 280 FEET WEST FROM THE SE CORNER OF SECTION 25; NW 1/4 SW 1/4, SECTION 8, T 2 S, R 11 E, W.M.; CREEK-1400 FEET NORTH AND 650 FEET EAST FROM THE SW CORNER OF SECTION 8.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 3 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
