CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

H.D. AND ROY HATHAWAY ROUTE 3, BOX 414 CORVALLIS, OREGON

confirms the right to use the waters of WILLAMETTE RIVER AND WILLAMETTE BASIN PROJECT RESERVOIRS CONSTRUCTED UNDER PERMITS R-1625 AND R-5363, tributaries of COLUMBIA RIVER, for the purpose of PRIMARY IRRIGATION OF 5.6 ACRES AND SUPPLEMENTAL IRRIGATION OF 358.7 ACRES.

The right has been perfected under Permit 43131. The date of priority is JUNE 16, 1978. The right is limited to not more than 0.07 CUBIC FOOT PER SECOND FROM WILLAMETTE RIVER AND 783.2 ACRE-FEET FROM WILLAMETTE BASIN PROJECT RESERVOIRS, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

LOT 6 (SE 1/4 SW 1/4), SECTION 30, LOT 2 (SW 1/4 NE 1/4), LOT 1 (NE 1/4 NW 1/4), SECTION 31, T 12 S, R 4 W, W.M.; 2060 FEET SOUTH AND 690 FEET WEST, 3000 FEET SOUTH AND 200 FEET WEST BOTH FROM THE CENTER 1/4 CORNER OF SECTION 30, 2790 FEET NORTH AND 2580 FEET EAST FROM THE SW CORNER OF SECTION 31; NE 1/4 NE 1/4, SE 1/4 NE 1/4, SE 1/4 SE 1/4, SECTION 25, T 12 S, R 5 W, W.M.; 2050 FEET NORTH AND 480 FEET WEST, 880 FEET NORTH AND 1225 FEET WEST, 1500 FEET SOUTH AND 70 FEET WEST, ALL FROM THE EAST 1/4 CORNER OF SECTION 25

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent from direct flow) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year from direct flow and storage. This right is subject to the terms and conditions of contracts No. 7-07-10-W0051 and 7-07-10-W0059, or satisfactory replacements between the Bureau of Reclamation and the applicant, copies of which are on file in the Water Resources Department.

The right is limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.
