CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of HIGHCROFT RESERVOIR, constructed under Permit R-8350, a tributary of BEAR CREEK, for the purpose of TEMPERATURE CONTROL FOR 45.6 ACRES.

The right has been perfected under Permit 46444. The date of priority is FEBRUARY 16, 1982. The right is limited to not more than 7.5 ACRE-FEET OF STORED WATER ONLY or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NE 1/4 SW 1/4 AS PROJECTED WITHIN DLC 61, SECTION 22, T 38 S, R 1 W, W.M.; 2000 FEET NORTH AND 2000 FEET EAST FROM THE SW CORNER OF SECTION 22.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

AS PROJECTED WITHIN DLC 62  
NE 1/4 NW 1/4 3.6 ACRES  
AS PROJECTED WITHIN DLC 61  
SECTION 27  
TOWNSHIP 38 SOUTH, RANGE 1 WEST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
