CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JOHN C. NELSON

confirms the right to use the waters of the APPELEGATE RIVER AND APPELEGATE LAKE RESERVOIR CONSTRUCTED UNDER PERMIT R-7810, a tributary of the ROGUE RIVER, for the purpose of the PRIMARY IRRIGATION OF 1.9 ACRES, SUPPLEMENTAL IRRIGATION OF 4.4 ACRES, AND DOMESTIC USE FOR ONE FAMILY.

The right has been perfected under Permit 47895. The date of priority is JULY 1, 1983. The right is limited to not more than 0.029 CUBIC FOOT PER SECOND, BEING 0.024 CFS FOR PRIMARY IRRIGATION AND 0.005 CFS FOR DOMESTIC USE FROM THE APPELEGATE RIVER, AND 6.0 ACRE-FEET STORED WATER FROM APPELEGATE RESERVOIR FOR SUPPLEMENTAL IRRIGATION, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

SE 1/4 NE 1/4, SECTION 28, T 39 S, R 3 W, W.M.; RIVER - 540 FEET NORTH AND 1630 FEET EAST FROM THE CENTER 1/4 CORNER OF SECTION 28. RESERVOIR-SE 1/4, SECTION 25, T 40 S, R 4 W, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second per acre (or its equivalent) and 4.5 acre-feet for each acre irrigated during the irrigation season of each year. The right is also subject to the terms and conditions of Contract No. 3-07-10-W0482, or a satisfactory replacement, between the Bureau of Reclamation and the applicant, a copy of which is on file in the records of the Water Resources Department. The supplemental portion of this right is limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

SE 1/4 NE 1/4 SECTION 28 TOWNSHIP 39 SOUTH, RANGE 3 WEST, W.M.	1.9 ACRES	4.4 ACRES AND DOMESTIC USE

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
