CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

MICHAEL W. WOOD, LOIS H. TRUELSON, AND HARLAN D. WOOD 7687 WILLIAMS HIGHWAY GRANTS PASS, OREGON 97527

confirms the right to use the waters of the APPLEGATE RIVER, a tributary of the ROGUE RIVER, for the purpose of IRRIGATING 12.4 ACRES.

The right has been confirmed by decree of the Circuit Court of the State of Oregon for JACKSON County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 16, at page 523. The date of priority is 1903.

The right is limited to not more than 0.26 CUBIC FOOT PER SECOND, IF AVAILABLE AT THE ORIGINAL POINT OF DIVERSION, (BUNCH-SWINDEN DITCH), SW 1/4 NE 1/4, SECTION 20, T 37 S, R 5 W, W.M.

The point of diversion is located as follows:

LOT 1 (SW 1/4 NW 1/4), SECTION 20, T 37 S, R 5 W, W.M.; 1550 FEET SOUTH AND 180 FEET EAST FROM THE NW CORNER OF SECTION 20.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

NE 1/4 NW 1/4 0.6 ACRE
LOT 1 (SW 1/4 NW 1/4) 8.8 ACRES
LOT 2 (SE 1/4 NW 1/4) 3.0 ACRES
SECTION 20

TOWNSHIP 37 SOUTH, RANGE 5 WEST, W.M.

This certificate is issued to confirm a change in POINT OF DIVERSION AND PLACE OF USE approved by orders of the Water Resources Director entered AUGUST 31, 1979 and MARCH 31, 1981, and together with certificate 49050, supersedes certificate 32833 State Record of Water Right Certificates.

Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.*

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and shall be subject to all other conditions and limitations contained in said decree.
