CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

MT. HOOD IRRIGATION DISTRICT
HOOD RIVER, OREGON 97031

confirms the right to use the waters of EAST FORK HOOD RIVER, a tributary of HOOD RIVER, for the purpose of IRRIGATING 924.2 ACRES.

The right has been confirmed by decree of the Circuit Court of the State of Oregon for HOOD RIVER County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 17, at page 333. The date of priority is NOVEMBER 27, 1895.

The right is limited to not more than 11.55 CUBIC FEET PER SECOND, IF AVAILABLE AT THE ORIGINAL POINT OF DIVERSION; SE 1/4 NE 1/4, SECTION 5, T 1 S, R 10 E, W.M.; MT. HOOD CANAL - 2320 FEET SOUTH AND 150 FEET WEST FROM THE NE CORNER SECTION 5.

The point of diversion is located as follows:

NW 1/4 SW 1/4, SECTION 4, T 1 S, R 10 E, W.M.; EAST FORK MAIN CANAL - 3750 FEET SOUTH AND 430 FEET EAST FROM NW CORNER SECTION 4.
