CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

MELVIN AND WILLIAM R. DURETTE

confirms the right to use the waters of SAGEBRUSH CREEK, a tributary of TROUT CREEK, for the purpose of IRRIGATING 143.5 ACRES.

The right has been perfected under Permit 36704. The date of priority is JUNE 20, 1972. The right is limited to not more than 3.59 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SE 1/4 SE 1/4, SECTION 21, T 9 S, R 14 E, W.M.; 950 FEET NORTH AND 760 FEET WEST FROM THE SE CORNER OF SECTION 21.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 6.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

This certificate describes that portion of the water right confirmed by certificate 55583, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered June 18, 1990, approving transfer application 6311.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
