CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

WELCH, COLLINS, DICKENSON, and WALLER BOX 572 TIOGA, NORTH DAKOTA Superseded by 67763 € 67710

confirms the right to use the waters of the ROGUE RIVER, a tributary of the PACIFIC OCEAN, for the purpose of DOMESTIC, STOCK, AND THE IRRIGATION OF 13.8 ACRES.

The right has been perfected under Permit 12635. The date of priority is MAY 7, 1937. The right is limited to not more than 0.193 CUBIC FOOT PER SECOND, BEING 0.01 CFS FOR DOMESTIC, 0.01 CFS FOR STOCK, AND 0.173 FOR IRRIGATION, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

LOT 1 (NE 1/4 NW 1/4) for Welch, Collins, and Dickenson, and LOT 1 (SE 1/4 NW 1/4) for Waller, SECTION 15, T 34 S, R 1 W, W.M.

The amount of water used for irrigation under this right is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

LOT 1 (SE 1/4 NW 1/4) DOMESTIC AND STOCK
LOT 1 (NE 1/4 NW 1/4) 0.90 ACRE (Welch)
LOT 1 (NE 1/4 NW 1/4) 0.75 ACRE (Collins)
LOT 1 (NE 1/4 NW 1/4) 2.00 ACRES (Dickenson)
LOT 1 (NE 1/4 NW 1/4) 3.15 ACRES (Waller)
LOT 1 (SE 1/4 NW 1/4) 7.00 ACRES (Waller)

TOWNSHIP 34 SOUTH, RANGE 1 WEST, W.M.

This certificate describes that portion of the water right confirmed by certificate 56208, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered June 20, 1990, approving transfer application T-5980.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
