CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of 3 WELLS in the LITTLE PUDDING RIVER BASIN for the purpose of the PRIMARY IRRIGATION OF 23.7 ACRES AND THE SUPPLEMENTAL IRRIGATION OF 298.3 ACRES.

This right has been perfected under Permit G-10594. The date of priority is MAY 21, 1985. This right is limited to 1.72 CUBIC FEET PER SECOND, BEING 0.30 CFS FOR PRIMARY IRRIGATION FROM WELLS 1, 2 AND 3 AND 1.72 CFS FOR SUPPLEMENTAL IRRIGATION FROM WELL 3, or its equivalent in case of rotation, measured at the well.

The wells are located as follows:

SW 1/4 SW 1/4, SE 1/4 SW 1/4, SECTION 11, T 8 S, R 2 W, W.M.; WELL 1 - 1800 FEET SOUTH AND 1850 FEET WEST, WELL 2 - 1750 FEET SOUTH AND 950 FEET WEST, WELL 3 - 2550 FEET SOUTH AND 520 FEET WEST, ALL FROM THE SW CORNER OF DLC 41.

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year. The right shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein.

This right shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the place of use under this right, and to which this right is appurtenant, is as follows:
