CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

W.J. KVARSTEN 4245 EAGLE CREST ROAD, N.W. SALEM, OREGON 97304

confirms the right to use the waters of SPRING 1, AN UNNAMED STREAM AND RESERVOIRS 1 AND 2, constructed under Permit R-6157, tributaries of SPRING VALLEY CREEK, for the purpose of the PRIMARY IRRIGATION OF 3.4 ACRES, SUPPLEMENTAL IRRIGATION OF 9.1 ACRES, FISH CULTURE, AND DOMESTIC USE FOR ONE FAMILY.

This right has been perfected under Permit 38076. The date of priority is NOVEMBER 22, 1972. This right is limited to 0.085 CUBIC FOOT PER SECOND; BEING 0.04 CFS FOR PRIMARY IRRIGATION FROM THE UNNAMED STREAM AND RESERVOIR 2, 0.04 CFS FOR FISH CULTURE FROM THE UNNAMED STREAM AND RESERVOIRS 1 AND 2, AND 0.005 CFS FOR DOMESTIC USE FROM SPRING 1, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

LOT 1 (NE 1/4 NE 1/4), SW 1/4 NE 1/4, SECTION 2, T 7 S, R 4 W, W.M.; UNNAMED STREAM AND RESERVOIR 1 - 1000 FEET SOUTH AND 920 FEET WEST; UNNAMED STREAM AND RESERVOIR 2 - 1170 FEET SOUTH AND 960 FEET WEST; SPRING 1 - 1410 FEET SOUTH AND 1400 FEET WEST; ALL FROM THE NE CORNER OF SECTION 2.

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) from direct flow and 2.5 acre-feet from direct flow and storage for each acre irrigated during the irrigation season of each year. The right shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein. This right is further limited to use the use of stored water on the lands described as supplemental.

This right shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the place of use under this right, and to which this right is appurtenant, is as follows:
