CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of the ALBANY SLOUGH, a tributary of WILLAMETTE RIVER, for the purpose of IRRIGATING 353.9 ACRES.

This right has been perfected under Permit 38190. The date of priority is JUNE 12, 1973. This right is limited to 2.5 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

LOT 3 (SE 1/4 SW 1/4), SECTION 7, T 13 S, R 4 W, W.M.; 4450 FEET SOUTH AND 140 FEET WEST FROM THE N 1/4 CORNER OF SECTION 7.

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year.

This right shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the place of use under this right, and to which this right is appurtenant, is as follows:
