CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JERREL W. HARLIEN

confirms the right to use the waters of MILL CREEK AND HULICK BRANCH, both tributaries of GRANDE RONDE RIVER, for the purpose of OUT OF SEASON IRRIGATION OF 98.0 ACRES.

The right has been perfected under Permit 44319. The date of priority is AUGUST 9, 1979. The right is limited to not more than 1.23 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

SW 1/4 NW 1/4, SW 1/4 SE 1/4, SECTION 16, T 3 S, R 40 E, W.M.; HULICK BRANCH - 730 FEET NORTH AND 1350 FEET WEST FROM THE CENTER 1/4 CORNER OF SECTION 16; MILL CREEK - 80 FEET NORTH AND 650 FEET EAST AND 70 FEET NORTH AND 80 FEET EAST, BOTH FROM THE SOUTH 1/4 CORNER OF SECTION 16.

This right is limited to a diversion ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of 1.0 acre-foot for each acre irrigated during the period from September 1 to March 31. This right, together with any other right existing for the same land, shall not exceed 3.0 acre-feet for each acre irrigated in any one year.

This use may be made any time between September 1 and March 31 when water can be put to beneficial use by irrigation, either for immediate crop growth or for forecast requirements to raise the soil moisture to field capacity in the soil profile to be utilized by plant growth in the subsequent growing season.

The use of water during the period from September 1 to March 31 as authorized herein shall not establish priority of right as against future appropriations of surface water for beneficial uses or for storage for such beneficial uses, other than similar rights for irrigation.

Sufficient flow shall be left in Mill Creek and Hulick Branch to provide stockwater throughout its course during the period of use authorized herein.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

SE 1/4 SW 1/4	12.0 ACRES

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
