confirms the right to use the waters of THE COLUMBIA RIVER, a tributary of THE PACIFIC OCEAN, for the purpose of IRRIGATING 4.0 ACRES AND INDUSTRIAL USE.

The right has been perfected under Permit 44001. The date of priority is MARCH 9, 1979. The right is limited to not more than 20.05 CUBIC FEET PER SECOND; BEING 0.05 CFS FOR IRRIGATION AND 20.0 CFS FOR INDUSTRIAL USE, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

LOT 1 (SW 1/4 SE 1/4), SECTION 28, T 2 N, R 13 E, W.M.; 550 FEET SOUTH AND 820 FEET EAST FROM THE SE CORNER OF DLC 39.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
