CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

CHARLES L. VAUGHN P.O. BOX 641 WINSTON, OREGON 97496

confirms the right to use the waters of AN UNNAMED STREAM AND A RESERVOIR constructed under Permit R-8992, a tributary of LOOKINGGLASS CREEK, for the purpose of the IRRIGATION OF 39.7 ACRES AND LIVESTOCK.

The right has been perfected under Permit 48006. The date of priority is AUGUST 25, 1983. The right is limited to not more than 0.23 CUBIC FOOT PER SECOND, BEING 0.225 CFS FOR IRRIGATION AND 0.005 CFS FOR LIVESTOCK, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

NW 1/4 NE 1/4, AS PROJECTED WITHIN DLC 49, SECTION 20, T 28 S, R 6 W, W.M.; 100 FEET SOUTH AND 560 FEET EAST; 430 FEET SOUTH AND 620 FEET EAST; BOTH FROM THE NORTH 1/4 CORNER OF SECTION 20.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated from direct flow and storage during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
