CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of AN UNNAMED STREAM, a tributary of CULLABY LAKE, for the purpose of SUPPLEMENTAL IRRIGATION, CHEMICAL APPLICATION, TEMPERATURE CONTROL AND FLOOD HARVESTING ON 7.5 ACRES OF CRANBERRIES.

The right has been perfected under Permit 47470. The date of priority is JANUARY 23, 1973 FOR 0.105 CFS FOR IRRIGATION; MAY 14, 1981 FOR 0.105 CFS FOR CHEMICAL APPLICATION, 0.105 CFS FOR TEMPERATURE CONTROL AND 1.96 CFS FOR FLOOD HARVESTING AND MARCH 24, 1983 FOR 0.085 CFS FOR IRRIGATION, 0.085 CFS FOR CHEMICAL APPLICATION AND 1.025 CFS FOR TEMPERATURE CONTROL. The right is limited to not more than 1.96 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SW 1/4 NE 1/4, AS PROJECTED WITHIN DLC 39, SECTION 27, T 7 N, R 10 W, W.M.; 120 FEET SOUTH AND 1080 FEET WEST FROM THE NE CORNER OF LOT 2 (SW 1/4 NE 1/4), SECTION 27.

For irrigation of cranberries, this right is limited to a diversion of ONE-FORTIETH of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year. For the irrigation of any other crop, this right is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year. This right is limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitations allowed herein.

This right shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the place of use under this right, and to which this right is appurtenant, is as follows:

LOT 1 (NW 1/4 NE 1/4) 0.9 ACRE
LOT 2 (SW 1/4 NE 1/4) 6.6 ACRES
SECTION 27
TOWNSHIP 7 NORTH, RANGE 10 WEST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
