Little Creek for Tracts #1 and #2: Catherine Creek for Tract #3;

for the purpose of Irrigation;

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Union County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume 8, at page 1; that the priority of the right thereby confirmed dates from 1870 for Tract #1; 1873 for Tract #2; Nov. 1903 for Tract #3;

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed. Three acre feet per acre in any irrigation season, diverted at a rate of not to exceed one-fortieth of a cubic foot per second per acre;

A description of the lands irrigated under such right, and to which the water is appurtenant (or, if for other purposes, the place where such water is put to beneficial use), is as follows:

- Tract #1: One hundred sixty (160) acres in the Southwest Quarter (SW2), Section Eleven (11), Township 4 South, Range 39 East of the Willamette Meridian.
- Tract #2: Two (2) acres in the Southwest Quarter of the Northwest Quarter (SWANWA) and Three (3) acres in the Southeast Quarter of the Northwest Quarter (SEANWA), Section Eighteen (18), Township Four (4) South, Range 40 East of the Willamette Meridian, being a total of 5 acres.
- Tract #3: Thirty-three and five tenths (33.5) acres in the Northwest Quarter of the Northeast Quarter (NW4NE4), Forty (40) acres in the Southwest Quarter of the Northeast Quarter (SW4NE4), Thirty-one and two tenths (31.2) acres in the Northeast Quarter of the Northwest Quarter (NE4NW4), Ten and one tenth (10.1) acres in the Southeast Quarter of the Northwest Quarter (SE4NW4), Section 15; Forty (40) acres in the Northwest Quarter of the Southwest Quarter (NW4SW4), Thirty-two and two tenths (32.2) acres in the Southwest Quarter of the Southwest Quarter (SW4SW4), Section 10; Thirty and seven tenths (30.7) acres in the Northeast Quarter of the Southeast Quarter (NE4SE4) and One and six tenths (1.6) acres in the Southeast Quarter of the Southeast Quarter (SEASE4) of Section 9, Township 4 South, Range 39 East, W.M., being a total of 219.3 acres.

The right to the use of the water for irrigation purposes is restricted to the lands or place of use herein described. And said right shall be subject to all other conditions and limitations contained in said decree.
