CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

WALTER JACK SCOTT 33763 TENNESSEE ROAD LEBANON, OREGON 97355

confirms the right to use the waters of GREEN PETER RESERVOIR, constructed under Permit R-5363, a tributary of the SOUTH SANTIAM RIVER, for the purpose of the SUPPLEMENTAL IRRIGATION OF 83.1 ACRES.

This right has been perfected under Permit 42237. The date of priority is JUNE 22, 1977. This right is limited to 200.81 ACRE FEET OF STORED WATER ONLY or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of re-diversion is located as follows:

NW 1/4 NW 1/4, AS PROJECTED WITHIN DLC 71, SECTION 1, T 12 S, R 2 W, W.M.; 850 FEET SOUTH AND 350 FEET EAST FROM THE NW CORNER OF SECTION 1.

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of 2.5 acre-feet for each acre irrigated during the irrigation season of each year. This right is subject to the terms and conditions of Contract No. 7-07-10-W0016, or a satisfactory replacement, between the Bureau of Reclamation and the applicant, a copy of which is on file in the Water Resources Department.

The right shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein.

This right shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the place of use under this right, and to which this right is appurtenant, is as follows:
