CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

DOUGLAS B. AND JOANN FRIES

confirms the right to use the waters of the WILLAMETTE RIVER, a tributary of the COLUMBIA RIVER, for the purpose of IRRIGATING 315.6 ACRES.

This right has been perfected under Permit 22063. The date of priority is JANUARY 29, 1953. This right is limited to 2.5 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

SE 1/4 NW 1/4, NE 1/4 SW 1/4, BOTH AS PROJECTED WITHIN DLC 72, SECTION 1, T 4 S, R 3 W, W.M.; 1950 FEET SOUTH AND 2310 FEET EAST, 3850 FEET SOUTH AND 2600 FEET EAST, BOTH FROM THE NW CORNER OF SECTION 1.

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year.

This right shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the place of use under this right, and to which this right is appurtenant, is as follows:

This certificate is issued to confirm a change in PLACE OF USE AND AN ADDITIONAL POINT OF DIVERSION approved by an order of the Water Resources Director entered JULY 26, 1977 and supersedes certificate 22232, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
