CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

CHARLES W. COLLINS  
198 MCKEE LANE  
ROSEBURG, OREGON 97470

confirms the right to use the waters of UMPQUA RIVER, a tributary of PACIFIC OCEAN, for the purpose of IRRIGATING 198.0 ACRES.

This right has been perfected under Permit 50194. The date of priority is OCTOBER 28, 1987. This right is limited to 2.48 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

SW 1/4 SW 1/4, NE 1/4 NW 1/4, SECTION 18, T 26 S, R 6 W, W.M.; DIVERSION POINT 1- 2200 FEET SOUTH AND 950 FEET WEST, DIVERSION POINT 2- 1420 FEET NORTH AND 1920 FEET EAST, BOTH FROM THE W 1/4 CORNER OF SECTION 18.

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year.

This right shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the place of use under this right, and to which this right is appurtenant, is as follows:
