CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of 2 WELLS in the LONG TOM RIVER BASIN for the purpose of IRRIGATING 139.4 ACRES.

This right has been perfected under Permit G-4761. The date of priority is DECEMBER 8, 1969. This right is limited to 1.56 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the wells.

The wells are located as follows:

NE 1/4 SW 1/4, NW 1/4 SE 1/4, BOTH AS PROJECTED WITHIN DLC 42, SECTION 3, T 14 S, R 5 W, W.M.; WELL 1 - 780 FEET SOUTH AND 720 FEET EAST; WELL 2 - 890 FEET SOUTH AND 2250 FEET EAST; BOTH FROM THE SW CORNER OF DLC 69.

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year.

This right shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the place of use under this right, and to which this right is appurtenant, is as follows:
