CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

TIM LILLEBO and JOE DONALDSON

BEND, OREGON 97701

confirms the right to use the waters of the JOHN DAY RIVER, a tributary of the COLUMBIA RIVER, for the purpose of IRRIGATING 2.7 ACRES.

The right has been confirmed by decree of the Circuit Court of the State of Oregon for GRANT County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 15, at page 461. The date of priority is 1870.

The right is limited to not more than 0.07 CUBIC FOOT PER SECOND .

The point of diversion is located as follows:

NE 1/4 SE 1/4, SECTION 7, T 13 S, R 34 E, W.M.; 3280 FEET SOUTH AND 4240 FEET EAST FROM THE NW CORNER OF SECTION 7.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated from APRIL 1 TO SEPTEMBER 30 and ONE ACRE FOOT PER ACRE PER MONTH TO JULY 1, THREE-FOURTHS ACRE FOOT PER ACRE PER MONTH THEREAFTER AND NOT MORE THAN 5.0 ACRE FEET PER ACRE PER SEASON, MEASURED AT THE POINT OF DIVERSION FROM THE RIVER.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

NW 1/4 SE 1/4 0.2 ACRE
SW 1/4 SE 1/4 2.5 ACRES
SECTION 2
TOWNSHIP 13 SOUTH, RANGE 33 EAST, W.M.

This certificate is issued to confirm a change in POINT OF DIVERSION approved by an order of the Water Resources Director entered JUNE 2, 1989, and together with certificate 61648, supersedes certificate 38303, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and shall be subject to all other conditions and limitations contained in said decree.
