CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of FIFTEENMILE CREEK, a tributary of THE COLUMBIA RIVER, for the purpose of IRRIGATING 36.3 ACRES.

This right was perfected under Permit 44313. The date of priority is MAY 19, 1990. This right is limited to 0.45 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

LOT 4 (NE 1/4 SW 1/4), SECTION 33; SW 1/4 NW 1/4, AS PROJECTED WITHIN DLC 37, SECTION 34, T 1 S, R 13 E, W.M.; 220 FEET NORTH FROM THE SW CORNER OF DLC 37; 260 FEET SOUTH AND 690 FEET WEST FROM THE NE CORNER OF DLC 37.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year.

This right shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the place of use under this right, and to which this right is appurtenant, is as follows:
