CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

GENE UNDERHILL  
82541 DUFUR VALLEY ROAD  
DUFUR, OREGON 97021

confirms the right to use the waters of FIFTEENMILE CREEK, a tributary of the COLUMBIA RIVER, for the purpose of IRRIGATING 148.2 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for WASCO County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 7, at page 406. The date of priority is 1885 FOR TRACT 1 AND 1856 FOR TRACT 2.

This right is limited to one acre foot per acre during any 30 day period up to July 1st and 3/4 acre foot per acre during any 30 day period thereafter not to exceed 3.0 acre feet per acre during the irrigation season of each year. The rate of flow shall not exceed ONE-FORTIETH cubic foot per second per acre after July 1st.

The points of diversion are located as follows:

NE 1/4 SW 1/4, SECTION 33, SW 1/4 NW 1/4, SECTION 34, T 1 S, R 13 E, W.M.; SIGMAN DITCH - 2480 FEET NORTH AND 2250 FEET EAST FROM THE SW CORNER OF SECTION 33; CREEK - 1620 FEET SOUTH AND 30 FEET EAST FROM THE NW CORNER OF SECTION 34.

This certificate describes that portion of the water right confirmed by certificate 49488, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered AUGUST 29, 1990, approving transfer application T-6277.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and shall be subject to all other conditions and limitations contained in said decree.
