confirms the right to use the waters of A WELL in the GRANDE RONDE RIVER BASIN for the purpose of THE PRIMARY IRRIGATION OF 232.2 ACRES AND THE SUPPLEMENTAL IRRIGATION OF 158.6 ACRES.

This right has been perfected under Permit G-9309. The date of priority is APRIL 23, 1981. This right is limited to 3.3 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the well.

The well is located as follows:

SW 1/4 NW 1/4, SECTION 10, T 3 S, R 39 E, W.M.; 2640 FEET NORTH AND 1320 FEET EAST FROM THE SW CORNER OF SECTION 10.

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year. The right shall be limited to any deficiency in the available supply of any prior right for the same land and shall not exceed the limitation allowed herein.

This right shall conform to any reasonable rotation system ordered by the proper state officer.
