CERTIFICATE OF WATER RIGHT

confirms the right to store the waters of AN UNNAMED STREAM, a tributary of MAXFIELD CREEK, WITH ANY DEFICIENCY IN SUPPLY TO BE DIVERTED AND STORED FROM PRICE CREEK, a tributary of the LUCKIAMUTE RIVER, in EMERY MOORE RESERVOIR, appropriated under Permit 45703, for the purpose of IRRIGATION AND MAINTAINING A WILDLIFE HABITAT.

The right to store these waters was been perfected under Reservoir Permit R-8259. The date of priority is JANUARY 9, 1981. The amount of water entitled to be stored each year under this right is not more than 166.4 ACRE-FEET, BEING 20.4 ACRE-FEET FOR WILDLIFE HABITAT AND 146.0 ACRE-FEET FOR IRRIGATION.

The right to store water from Price Creek is a supplemental right and is limited to a diversion of water from Price Creek to the extent necessary to make up any deficiency in the available water to be stored under any prior right existing for the same reservoir.

The reservoir is located as follows:

Points of diversion are located:

NE 1/4 NW 1/4, AS PROJECTED WITHIN DLC 45, SECTION 22, LOT 3(NW 1/4 NE 1/4), SECTION 27, T 10 S, R 6 W, W.M.; UNNAMED STREAM- 4170 FEET NORTH AND 2530 FEET EAST, PRICE CREEK - 1150 SOUTH AND 3130 FEET EAST; BOTH FROM THE SW CORNER OF SECTION 22.

The right to store and use the water for the above purpose is restricted to beneficial use at the place of use described.
