## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

WILLIAM S. AND IRIS A. LOSHBAUGH P.O. BOX 857 BANDON, OREGON 97411

confirms the right to use the waters of GREEN GULCH CREEK, a tributary of FOURMILE CREEK, for the purpose of IRRIGATION, TEMPERATURE CONTROL AND FLOOD HARVESTING OF 0.81 ACRE OF CRANBERRIES, AND TEMPERATURE CONTROL AND HARVESTING OF 2.80 ACRES OF CRANBERRIES.

This right was perfected under Permit 41306. The date of priority is OCTOBER 18, 1974. This right is limited to 0.29 CUBIC FOOT PER SECOND; BEING 0.02 CFS FOR IRRIGATION, 0.17 CFS FOR CRANBERRY HARVESTING, AND 0.29 CFS FOR TEMPERATURE CONTROL, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NW 1/4 NE 1/4, SECTION 12, T 30 S, R 15 W, W.M.; 850 FEET SOUTH AND 1070 FEET EAST FROM THE NORTH 1/4 CORNER OF SECTION 12.

The amount of water used for irrigation of cranberries, together with the amount secured under any other right existing for the same lands, is limited to one-fortieth of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year. The irrigation of any other crop is limited to a division of one-eightieth of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year. This right shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the place of use under this right, and to which this right is appurtenant, is as follows:

IRRIGATION, TEMPERATURE CONTROL AND HARVESTING NW 1/4 NE 1/4 0.53 ACRE NE 1/4 NW 1/4 0.28 ACRE SECTION 12 TOWNSHIP 30 SOUTH, RANGE 15 WEST, W.M.

> TEMPERATURE CONTROL AND HARVESTING NW 1/4 NE 1/4 1.40 ACRES NE 1/4 NW 1/4 1.40 ACRES SECTION 12 TOWNSHIP 30 SOUTH, RANGE 15 WEST, W.M.

This certificate is issued to correctly describe the water right perfected under permit 41306 and supercedes certificate 53998, State Record of Water Right Certificates.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
