## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

HAROLD KRAEMER 13318 DOMONIC ROAD MOUNT ANGEL, OREGON 97362

confirms the right to use the waters of 2 WELLS in the ZOLNER CREEK BASIN for the purpose of SUPPLEMENTAL IRRIGATION OF 325.6 ACRES.

The right has been perfected under Permit G-8954. The date of priority is MAY 13, 1980. The right is limited to not more than 4.18 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the well.

The wells are located as follows:

NW 1/4 NW 1/4, AS PROJECTED WITHIN DLC 43, SE 1/4 NW 1/4, AS PROJECTED WITHIN DLC 48, SECTION 17, T 6 S, R 1 E, W.M.; LONE PINE WELL - 150 FEET SOUTH AND 2590 FEET EAST, WELL 1 - 90 FEET NORTH AND 600 FEET EAST, BOTH FROM THE NW CORNER DLC 48.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein.

IF WATER FROM EITHER OR BOTH WELLS IS PLACED INTO BUTTE CREEK AS A MEANS OF DELIVERY TO THE LANDS, THE AMOUNT OF WATER PLACED INTO BUTTE CREEK FROM THE WELLS SHALL BE MEASURED BY A FLOW METER OR OTHER DEVICE APPROVED BY THE WATERMASTER. THE AMOUNT OF WATER REMOVED FROM BUTTE CREEK PROVIDED BY EITHER OR BOTH WELLS SHALL ALSO BE MEASURED AT EACH POINT OF DIVERSION FROM BUTTE CREEK. MEASUREMENT FROM BUTTE CREEK SHALL BE MADE BY A FLOW METER OR OTHER DEVICE APPROVED BY THE WATERMASTER. THE TOTAL QUANTITY OF WATER REMOVED FROM BUTTE CREEK UNDER THIS RIGHT SHALL NOT EXCEED THE QUANTITY OF WATER PLACED INTO BUTTE CREEK FROM THE WELLS AT ANY TIME LESS ANY TRANSMISSION LOSSES. TRANSMISSION LOSSES SHALL BE DETERMINED BY THE WATERMASTER.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
