confirms the right to use the waters of THREE WELLS in the FLORAS LAKE BASIN for the purpose of TEMPERATURE CONTROL, FLOOD HARVEST, AND SUPPLEMENTAL IRRIGATION OF 67.87 ACRES OF CRANBERRIES.

The right has been perfected under Permit G-10027. The date of priority is JANUARY 12, 1983. The right is limited to 280 GALLONS PER MINUTE; BEING 100 GPM FROM WELL A, 80 GPM FROM WELL B AND 100 GPM FROM WELL C, or its equivalent in case of rotation, measured at the well.

The wells are located as follows:

SE 1/4 SW 1/4, SECTION 29, NE 1/4 NW 1/4, SE 1/4 NW 1/4, SECTION 32, T 31 S, R 15 W, W.M.; WELL A - 262 FEET SOUTH AND 415 FEET WEST, WELL B - 2125 FEET SOUTH AND 260 FEET WEST, WELL C - 600 FEET NORTH AND 600 FEET WEST, ALL FROM THE SOUTH 1/4 CORNER OF SECTION 29.

The amount of water used for irrigation of cranberries, together with the amount secured under any other right existing for the same lands, is limited to a diversion of one-fortieth of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year. For the irrigation of any other crop this right is limited to a diversion of one-eightieth of one cubic foot per second (or its equivalent) and 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year. The right shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

SE 1/4 SW 1/4 19.74 ACRES SECTION 29

NE 1/4 NW 1/4 24.60 ACRES SE 1/4 NW 1/4 23.53 ACRES

SECTION 32

TOWNSHIP 31 SOUTH, RANGE 15 WEST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
