CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of TWO UNNAMED STREAMS AND TWO RESERVOIRS, a tributary of FLORAS LAKE, for the purpose of TEMPERATURE CONTROL, FLOOD HARVESTING AND IRRIGATION OF 44.07 ACRES OF CRANBERRIES.

The right has been perfected under Permit 47420. The date of priority is OCTOBER 7, 1982. The right is limited to not more than 0.28 CUBIC FOOT PER SECOND FROM UNNAMED STREAM 1, 0.13 CFS FROM UNNAMED STREAM 2 AND 27.0 ACRE FEET OF STORED WATER, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

NE 1/4 SW 1/4, SE 1/4 SW 1/4, SECTION 29, NE 1/4 NW 1/4, SE 1/4 NW 1/4, SECTION 32, T 31 S, R 15 W, W.M.; STREAM 1 - 460 FEET EAST, STREAM 2 - 180 FEET EAST BOTH FROM THE NORTHWEST CORNER OF NE 1/4 SW 1/4 SECTION 29, RESERVOIR C - 690 FEET NORTH AND 735 FEET WEST, RESERVOIR A - 715 FEET SOUTH AND 385 FEET WEST, 1995 FEET SOUTH AND 260 FEET W ALL FROM THE NORTH 1/4 CORNER OF SECTION 32.

The amount of water used for irrigation of cranberries, together with the amount secured under any other right existing for the same lands, is limited to a diversion of one-fortieth of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year. For the irrigation of any other crop this right is limited to a diversion one-eightieth of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year. The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

SE 1/4 SW 1/4     19.74  
SECTION 29  
  
NE 1/4 NW 1/4     12.30  
SE 1/4 NW 1/4     12.03  
SECTION 32  
TOWNSHIP 31 SOUTH, RANGE 15 WEST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
