CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of TWO WELLS in the COLUMBIA RIVER BASIN for the purpose of IRRIGATION OF 1.08 ACRES AND INDUSTRIAL USES AT A SANITARY LANDFILL TO INCLUDE DUST CONTROL, CONSTRUCTION WATERING AND EQUIPMENT WASHDOWN.

This right has been perfected under Permit G-10808. The date of priority is MARCH 25, 1988. This right is limited to 600 GALLONS PER MINUTE; BEING 6 GPM FOR IRRIGATION AND 594 GPM FOR INDUSTRIAL USE, or its equivalent in case of rotation, measured at the well.

The wells are located as follows:

NW 1/4 NE 1/4, SE 1/4 NE 1/4, SECTION 31, T 2 N, R 21 E, W.M.; WELL 1 - 1580 FEET SOUTH AND 200 FEET WEST, WELL 2 - 940 FEET SOUTH AND 1560 FEET WEST, BOTH FROM THE NE CORNER OF SECTION 31.

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year.

This right shall conform to any reasonable rotation system ordered by the proper state officer.
