## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

RICHARD JORDAN, SR. BOX 188 WESTFALL, OREGON 97720

confirms the right to use the waters of BULLY CREEK, a tributary of the MALHUER RIVER, for the purpose of IRRIGATING 82.0 ACRES.

The right has been perfected under Permit 38951. The date of priority is FEBRUARY 11, 1974. The right is limited to not more than 2.05 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

SE 1/4 SW 1/4, SE 1/4 NE 1/4, SECTION 18, T 18 S, R 43 E, W.M.; 100 FEET NORTH AND 1410 FEET EAST FROM THE SW CORNER OF SECTION 18, 90 FEET NORTH AND 1100 FEET WEST FROM THE EAST 1/4 CORNER OF SECTION 18.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
