CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

LARRY A. MILLER

LOSTINE, OREGON 97857

confirms the right to use the waters of AN UNNAMED SPRING, 3 UNNAMED STREAMS AND THREE RESERVOIRS CONSTRUCTED UNDER PERMIT R-6322 all tributaries of LOSTINE RIVER, for the purpose of THE IRRIGATION OF 0.8 ACRE, RECREATION, AND DOMESTIC USE FOR ONE FAMILY.

The right has been perfected under Permit 39461. The date of priority is JANUARY 6, 1975. The right is limited to not more than 0.045 CUBIC FOOT PER SECOND; BEING 0.020 CFS FROM THE SPRING FOR IRRIGATION, 0.005 CFS FROM THE SPRING FOR DOMESTIC AND 0.02 CFS FROM ALL SOURCES FOR RECREATION, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

LOT 15 (SW 1/4 SE 1/4), SECTION 8, LOT 2 (NW 1/4 NE 1/4), SECTION 17, T 1 S, R 43 E, W.M.; UNNAMED SPRING - 700 FEET SOUTH AND 860 FEET WEST, UNNAMED STREAM 1 - 1470 FEET SOUTH AND 490 FEET WEST, BOTH FROM THE NE CORNER OF LOT 15 (SW 1/4 SE 1/4) OF SECTION 8; UNNAMED STREAM 2 - 140 FEET SOUTH AND 870 FEET EAST, UNNAMED STREAM 3 - 180 FEET SOUTH AND 760 FEET EAST, BOTH FROM THE NORTH 1/4 CORNER OF SECTION 17.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

LOT 15 (SW 1/4 SE 1/4) 0.8 ACRE, DOMESTIC AND RECREATION
SECTION 8
TOWNSHIP 1 SOUTH, RANGE 43 EAST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
