CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

THE CONFEDERATED TRIBES OF WARM SPRINGS INDIAN RESERVATION BOX C WARM SPRINGS, OREGON 97761

confirms the right to use the waters of CAMPBELL CREEK, a tributary of DESCHUTES RIVER, for the purpose of SUPPLEMENTAL IRRIGATION OF 262.1 ACRES.

This right has been perfected under Permit 45835. The date of priority is JULY 11, 1980 FOR 5.26 CFS, APRIL 22, 1981 FOR 1.02 CFS AND JUNE 23, 1981 FOR 0.27 CFS. This right is limited to 6.55 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SE 1/4 NE 1/4, SECTION 7, T 10 S, R 13 E, W.M.; 70 FEET NORTH AND 1230 FEET WEST FROM THE E 1/4 CORNER OF SECTION 7.

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second (or its equivalent) and 4.0 acre-feet for each acre irrigated during the irrigation season of each year.

The right shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein.

This right shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the place of use under this right, and to which this right is appurtenant, is as follows:
