CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ROBERT J. MILLER 870 LYNN DRIVE ORANGE, CALIFORNIA 92667

confirms the right to use the waters of APPLEGATE RIVER AND APPLEGATE LAKE RESERVOIR CONSTRUCTED UNDER PERMIT R-7810, a tributary of ROGUE RIVER, for the purpose of IRRIGATING 4.2 ACRES.

The right has been perfected under Permit 46947. The date of priority is SEPTEMBER 8, 1982 FOR APPLEGATE RIVER AND AUGUST 19, 1982 FOR APPLEGATE LAKE RESERVOIR. The right is limited to not more than 0.05 CUBIC FOOT PER SECOND FROM APPLEGATE RIVER AND 5.0 ACRE-FEET OF STORED WATER ONLY FROM APPLEGATE LAKE RESERVOIR, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

SE 1/4 SW 1/4, SECTION 5, T 37 S, R 6 W, W.M.; 580 FEET NORTH AND 1850 FEET EAST FROM THE SW CORNER OF SECTION 5. APPLEGATE DAM LOCATED WITHIN THE S 1/2 SE 1/4, SECTION 25, T 40 S, R 4 W, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to one-eightieth of one cubic foot per second (or its equivalent) and 4.5 acre-feet for each acre irrigated during the irrigation season of each year. The right is subject to the terms and conditions of Contract No. 2-07-10-W0470, or a satisfactory replacement, between the Bureau of Reclamation and the applicant, a copy of which is on file in the records of the Water Resources Department.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

SE 1/4 SW 1/4 4.2 ACRES
SECTION 5
TOWNSHIP 37 SOUTH, RANGE 6 WEST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
