CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of CHICKEN CREEK, a tributary of TUALATIN RIVER, for the purpose of IRRIGATING 86.2 ACRES.

This right was perfected under Permit 46885. The date of priority is JUNE 28, 1982 FOR 1.01 CFS AND JUNE 30, 1982 FOR 0.07 CFS. This right is limited to 1.08 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

NE 1/4 SE 1/4, AS PROJECTED WITHIN DLC 41, SECTION 19, NE 1/4 SW 1/4, AS PROJECTED WITHIN DLC 41, SECTION 20, T 2 S, R 1 W, W.M.; 1450 FEET NORTH AND 570 FEET EAST, 1080 FEET NORTH AND 3450 FEET EAST, BOTH FROM THE SW CORNER OF DLC 41.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year. This right shall conform to any reasonable rotation system ordered by the proper state officer.

NO WATER SHALL BE APPROPRIATED UNDER THIS RIGHT DURING THE PERIOD OF JULY 31 THROUGH SEPTEMBER 15.

A description of the place of use under this right, and to which such right is appurtenant, is as follows:
