CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of the LOST CREEK RESERVOIR, a tributary of the ROGUE RIVER, for the purpose of the SUPPLEMENTAL IRRIGATION OF 24.0 ACRES.

This right has been perfected under Permit 50173. The date of priority is AUGUST 12, 1987. This right is limited to 24.0 ACRE-FEET STORED WATER ONLY, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

LOST CREEK DAM: SW 1/4 AND W 1/2 SW 1/4, SECTION 26, T 33 S, R 1 E, W.M.; REDIVERSION FROM THE ROGUE RIVER: LOT 5 (SW 1/4 SW 1/4), SECTION 29, T 35 S, R 1 W, W.M.; 280 FEET NORTH AND 1740 FEET EAST FROM THE SW CORNER OF SECTION 29.

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of not to exceed 4.5 acre-feet (or its equivalent) for each acre irrigated during the irrigation season of each year. The right shall be limited to any deficiency in the available supply of any prior right for the same land and shall not exceed the limitation allowed herein. This right is also subject to the terms and conditions of Contract 7-07-10-W0691 between the Bureau of Reclamation and the applicant, or a satisfactory replacement, a copy of which is on file in the records of the Water Resources Department.

This right shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the place of use under this right, and to which this right is appurtenant, is as follows:

LOT 5 (SW 1/4 SW 1/4) 18.8 ACRES
LOT 5 (SE 1/4 SW 1/4) 5.2 ACRES
SECTION 29
TOWNSHIP 35 SOUTH, RANGE 1 WEST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
