CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of SOUTH FORK OF THE COQUILLE RIVER a tributary of THE COQUILLE RIVER AND A SPRING, a tributary of ROWLAND CREEK, for the purpose of DOMESTIC USE FOR TWO FAMILIES AND LIVESTOCK WATERING.

This right has been perfected under Permit 50434. The date of priority is MAY 5, 1988. This right is limited to 0.04 CUBIC FOOT PER SECOND; BEING 0.01 CFS FROM SOUTH FORK COQUILLE RIVER FOR DOMESTIC USE, 0.02 CFS FROM SOUTH FORK COQUILLE RIVER FOR LIVESTOCK WATERING AND 0.01 CFS FROM THE SPRING FOR LIVESTOCK WATERING, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversions are located as follows:

SW 1/4 NW 1/4, SECTION 33, NE 1/4 NW 1/4, AS PROJECTED WITHIN DLC 37, SECTION 34, T 30 S, R 12 W, W.M.; SPRING - 64 FEET NORTH AND 4 FEET EAST FROM THE W 1/4 CORNER OF SECTION 33, RIVER - 1.3 FEET NORTH AND 2396 FEET EAST FROM THE SW CORNER OF THE NW 1/4 NW 1/4, SECTION 34.

This right shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the place of use under this right, and to which this right is appurtenant, is as follows:

COQUILLE RIVER  
NE 1/4 NW 1/4 DOMESTIC- LIVESTOCK WATER  
AS PROJECTED WITHIN DLC 37

TOWNSHIP 30 SOUTH, RANGE 12 WEST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. This right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
