CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

L.S. KELSEY
NORTH POWDER, OREGON 97867

confirms the right to use the waters of WOLF CREEK AND NORTH POWDER RIVER, a tributary of POWDER RIVER, for the purpose of PRIMARY IRRIGATION OF 54.5 ACRES AND SUPPLEMENTAL IRRIGATION OF 284.0 ACRES.

This right was perfected under Permit 2173. The date of priority is OCTOBER 14, 1911. This right is limited to 4.23 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

THE KELSEY-MOORE DITCH AND THE SUNNYSLOPE DITCH

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated during the irrigation season of each year. The right allowed herein is limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein.

This right shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the place of use under this right, and to which this right is appurtenant, is as follows:
