CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

CASPER AND MATHILDA OTT 3568 BLANCHET AVENUE ST. PAUL, OREGON 97137

confirms the right to use the waters of the WILLAMETTE RIVER, a tributary of the COLUMBIA RIVER, for the purpose of IRRIGATING 41.2 ACRES.

This right has been perfected under Permit 48832. The date of priority is JULY 31, 1984. This right is limited to 0.52 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NW 1/4 SE 1/4, AS PROJECTED WITHIN DLC 69, SECTION 13, T 4 S, R 3 W, W.M.; 2340 FEET NORTH AND 2150 FEET WEST FROM THE SE CORNER OF SECTION 13.

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year.

This right shall conform to any reasonable rotation system ordered by the proper state officer.
