## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

BEDORTHA RANCHES, INC. P.O. BOX 14 PAULINA, OREGON 97751

confirms the right to use the waters of 4 WELLS in the ALKALI CREEK BASIN for the purpose of IRRIGATING 441.8 ACRES.

This right has been perfected under Permit G-7345. The date of priority is JANUARY 11, 1977. This right is limited to 5.53 CUBIC FEET PER SECOND; BEING 2.05 CFS FROM WELL 8, 2.11 CFS FROM WELLS 9 AND 10, AND 1.37 CFS FROM WELL 11, or its equivalent in case of rotation, measured at the well.

The wells are located as follows:

LOT 4 (SW 1/4 SW 1/4), LOT 2 (SW 1/4 NW 1/4), SE 1/4 NW 1/4 SECTION 31, T 16 S, R 24 E, W.M.; WELL 8 - 350 FEET NORTH AND 80 FEET EAST, WELL 9 - 3260 FEET NORTH AND 280 FEET EAST, WELL 10 - 3390 FEET NORTH AND 260 FEET EAST, WELL 11 - 3290 FEET NORTH AND 2530 FEET EAST, ALL FROM THE SW CORNER OF SECTION 31.

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year.

This right shall conform to any reasonable rotation system ordered by the proper state officer.
