CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

METROPOLITAN WASTEWATER MANAGEMENT COMMISSION

confirms the right to use the waters of 2 WELLS in the WILLAMETTE RIVER BASIN for the purpose of INDUSTRIAL USE AND SUPPLEMENTAL IRRIGATION OF 189.1 ACRES.

The right has been perfected under Permit G-10369. The date of priority is NOVEMBER 22, 1982, FOR 0.20 CFS AND JANUARY 31, 1983, FOR 0.98 CFS. The right is limited to not more than 1.18 CUBIC FEET PER SECOND; BEING 0.20 CFS FROM WELL 1 FOR INDUSTRIAL USE AND 0.98 CFS FROM WELL 2 FOR SUPPLEMENTAL IRRIGATION, or its equivalent in case of rotation, measured at the well.

The wells are located as follows:

NW 1/4 NW 1/4, SECTION 34, T 16 S, R 4 W, W.M.; WELL 1-1090 FEET SOUTH AND 1440 FEET WEST, WELL 2 - 1350 FEET SOUTH AND 1900 FEET WEST, BOTH FROM THE NW CORNER OF DLC 44.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year. The right shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
