confirms the right to use the waters of TWO WELLS in the WILLAMETTE RIVER BASIN, for the purpose of IRRIGATING 43.5 ACRES.

The right has been perfected under Permit G-10844. The date of priority is NOVEMBER 25, 1987. The right is limited to not more than 0.55 CUBIC FOOT PER SECOND; BEING 0.26 CFS FROM WELL 1 AND 0.29 CFS FROM WELL 2, or its equivalent in case of rotation, measured at the well.

The wells are located as follows:

NE 1/4 SW 1/4 AS PROJECTED WITHIN DLC 43, SECTION 18, T 9 S, R 3 W, W.M.; WELL 1 - 850 FEET SOUTH AND 2905 FEET WEST FROM THE NE CORNER OF PETER POLLY DLC 43.

SE 1/4 NE 1/4 AS PROJECTED WITHIN DLC 53, SECTION 13, T 9 S, R 4 W, W.M.; WELL 2 - 1700 FEET SOUTH AND 700 FEET WEST FROM THE NE CORNER OF PETER POLLY DLC 53.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.
