CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

WILLIAM AND MARGARET OBERTEUFFER 70417 FOLLET ROAD ELGIN, OREGON 97827

confirms the right to use the waters of A SPRING, AN UNNAMED STREAM, AND A RESERVOIR CONSTRUCTED UNDER PERMIT R-6303, a tributary of RYDSAM CREEK, for the purpose of DOMESTIC USE FOR ONE FAMILY, IRRIGATION OF 0.4 ACRE, LIVESTOCK, AND FISH CULTURE.

The right has been perfected under Permit 39366. The date of priority is DECEMBER 11, 1974. The right is limited to not more than 0.065 CUBIC FOOT PER SECOND; BEING 0.005 CFS FROM THE SPRING FOR DOMESTIC USE, 0.01 CFS FOR IRRIGATION, 0.01 CFS FROM THE UNNAMED STREAM FOR LIVESTOCK AND 0.04 CFS FROM THE UNNAMED STREAM AND RESERVOIR FOR FISH CULTURE, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

NE 1/4 NW 1/4, SECTION 13, T 1 N, R 40 E, W.M.; UNNAMED STREAM-1900 FEET NORTH AND 420 FEET WEST; SPRING - 1860 FEET NORTH AND 260 FEET WEST; BOTH FROM THE CENTER 1/4 CORNER OF SECTION 13.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

NE 1/4 NW 1/4 0.4 ACRE, DOMESTIC, LIVESTOCK, FISH CULTURE NW 1/4 NW 1/4 FISH CULTURE SECTION 13

TOWNSHIP 1 NORTH, RANGE 40 EAST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
