CERTIFICATE OF WATER RIGHT

(For Rights which have been confirmed by the Courts)

This is to Certify, That JAMES RICE AND HAROLD BALDWIN, of Prineville State of Oregon has a right to the use of the waters of Crooked River, a tributary of Deschutes River,

for the purpose of the irrigation of 404 acres of land, and stock and domestic use,

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Crook County, and the said decree entered of record at Salem, in the Order Record of the STATE WATER BOARD of the State of Oregon, in Volume 1, at page 449 ; that the priority of the right hereby confirmed dates from the year 1900,

that the amount of water to which such right is entitled and hereby confirmed for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed a reasonable amount for stock and domestic use, and 5.05 cubic feet per second from July 1st to September 15th of each year for irrigation. The use hereunder shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the lands irrigated under such right, and to which the water hereby confirmed is appurtenant, or, if for other purposes, the place where such water is put to beneficial use, is as follows:

2 acres in the SW 1/4 of NW 1/4; 38 acres in the SE 1/4 of NW 1/4; 14 acres in the NW 1/4 of SW 1/4; 32 acres in the SW 1/4 of SW 1/4; Section Eighteen (18): 36 acres in the NE 1/4 of NW 1/4; 39 acres in the NW 1/4 of NW 1/4; 40 acres in the SW 1/4 of NW 1/4; 30 acres in the SE 1/4 of NW 1/4; 6 acres in the NE 1/4 of SW 1/4; 40 acres in the NW 1/4 of SW 1/4; 30 acres in the SW 1/4 of SW 1/4; Section Nineteen (19): all in Township Fifteen (15) South Range Sixteen (16) East of Willamette Meridian. 8 acres in the NE 1/4 of NE 1/4; 22 acres in the SE 1/4 of NE 1/4; 35 acres in the NE 1/4 of SE 1/4; 32 acres in the SE 1/4 of SE 1/4; Section Twenty-four (24) Township Fifteen (15) South Range Fifteen (15) East of Willamette Meridian, in Crook County, Oregon.

Note: The limited irrigation season of 1st Sept. to 15th Sept. and should conform to the season as shown in the Decree. See document filed adjacent to Certificate 815.

The right to the use of the water aforesaid hereby confirmed is restricted to the lands or place of use herein described.
