CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

METROPOLITAN WASTEWATER MANAGEMENT COMMISSION
225 NORTH 5TH STREET, SUITE 292

confirms the right to use CANNERY WASTEWATER AND A RESERVOIR CONSTRUCTED UNDER PERMIT R-9852, a tributary of FLAT CREEK, for the purpose of IRRIGATING 189.1 ACRES.

The right has been perfected under Permit 48474. The date of priority is JANUARY 31, 1983. The right is limited to not more than 2.36 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

WASTEWATER - NW 1/4 NW 1/4, SECTION 32, T 17 S, R 4 W, W.M.;
1060 FEET SOUTH AND 520 FEET EAST FROM THE NW CORNER OF SECTION 32,
RESERVOIR - NW 1/4 NW 1/4, SECTION 34, T 16 S, R 4 W, W.M.; 300
FEET SOUTH AND 800 FEET EAST FROM THE NW CORNER OF SECTION 34.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to 1/80 of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage. This right is subject to the terms and provisions of an order of the Water Resources Director dated October 13, 1983, and recorded at Volume 37, pages 496-503, Special Order Records.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
