CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

MCNULTY WATER ASSOCIATION
P.O. BOX 177
SAINT HELENS, OREGON 97051

has a right to the use of the waters of WELL #1 in the COLUMBIA RIVER BASIN for the purpose of QUASI-MUNICIPAL USES.

The right has been perfected under Permit G-8026. The date of priority is NOVEMBER 20, 1968. The right is limited to not more than 0.6 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the well.

The well is located as follows:

SW 1/4 SE 1/4, SECTION 12, T 4 N, R 2 W, W.M.; NORTH 79 DEGREES WEST & 2610 FEET FROM SE CORNER SECTION 12.

This right is subject to the terms and conditions of a stipulation recorded in Book 47, page 886, records of the Columbia County Clerk, a copy of which is on file with the Water Resources Department.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.
