CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of A SUBSURFACE DRAIN AND SUMP in the WILLOW CREEK BASIN for the purpose of the PRIMARY IRRIGATION OF 126.5 ACRES AND THE SUPPLEMENTAL IRRIGATION OF 113.8 ACRES.

This right has been perfected under Permit G-6713. The date of priority is MARCH 8, 1976. This right is limited to 1.65 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the sump.

The sump is located as follows:

SW 1/4 NW 1/4, SECTION 4, T 8 S, R 39 E, W.M.; 1380 FEET SOUTH AND 1170 FEET EAST FROM THE NW CORNER OF SECTION 4.

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year. The right shall be limited to any deficiency in the available supply of any prior right for the same land and shall not exceed the limitation allowed herein, and shall be further limited to appropriation of water only to the extent that it does not impair or substantially interfere with existing surface water rights of others.

This right shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the place of use under this right, and to which this right is appurtenant, is as follows:
