CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

HAROLD KRAEMER
13318 DOMNIC ROAD
MT. ANGEL, OREGON 97362

confirms the right to use the waters of TWO WELLS in the BUTTE CREEK BASIN for SUPPLEMENTAL IRRIGATION OF 81.0 ACRES.

This right was perfected under Permit G-10144. The date of priority is SEPTEMBER 20, 1983. This right is limited to 0.514 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the wells.

The wells are located as follows:

NW 1/4 NW 1/4, SE 1/4 NW 1/4, SECTION 17, T 6 S, R 1 E, W.M.;
1200 FEET SOUTH AND 80 FEET EAST, 1470 FEET SOUTH AND 1990 FEET EAST,
BOTH FROM THE NW CORNER OF SECTION 17.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year. This right is limited to any deficiency in the available supply of any prior right existing for the same land.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

SW 1/4 SW 1/4 35.0 ACRES
SECTION 6

NE 1/4 NW 1/4 11.0 ACRES
NW 1/4 NW 1/4 35.0 ACRES
SECTION 7

TOWNSHIP 6 SOUTH; RANGE 1 EAST, W.M.

This certificate describes that portion of the water right confirmed by Certificate 62398, State Record of Water Right Certificates, NOT modified by the provisions of orders of the Water Resources Director entered JANUARY 7, 1991, cancelling a portion of this water right and approving Transfer Application 6360.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
