## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

DESCHUTES VALLEY FARMS, INC. 809 SOUTH CANYON DRIVE REDMOND, OREGON 97756

confirms the right to use the waters of TWO WELLS in the DEEP CANYON CREEK BASIN for the purpose of THE PRIMARY IRRIGATION OF 239.0 ACRES AND THE SUPPLEMENTAL IRRIGATION OF 71.5 ACRES.

The right has been perfected under Permit G-4974. The date of priority is MARCH 13, 1972. The right is limited to not more than 3.88 CUBIC FEET PER SECOND, BEING 0.73 CFS FROM WELL 1 AND 3.15 CFS FROM WELL 2, or its equivalent in case of rotation, measured at the wells.

The wells are located as follows:

SW 1/4 SE 1/4, SECTION 18, NW 1/4 SW 1/4, SECTION 19, T 14 S, R 12 E, W.M.; WELL 1 - 1050 FEET NORTH AND 6980 FEET WEST FROM THE SE CORNER OF SECTION 17; WELL 2 - 2380 FEET NORTH AND 4420 FEET WEST FROM THE SE CORNER OF SECTION 19.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
